## 1. Services Provided

## 3. Payment Terms

- \$100 nonrefundable deposit due a time of booking ( booking payment is credit towards entire modeling fee, and locks in booking date)
- Full payment due DAY OF the shoot ( zelle, venmo, cashapp, cash)
- Rates are to be negotiated and agreed upon between client and model in advance

## 4. Rights and Usage

- Usage Rights: The Client is granted the following rights to use the images and videos taken during the modeling session:

- 24hr client cancellation notice will allow client to rebook model and use \$100 deposit within 30 days of canceled date notice

- "Day of" client cancelation = no deposit return

- Client tardiness 30min or greater to booking date will either

1. allow shoot to still happen and will still end at time stated on contract.  
photographer MUST still pay for FULL MODEL PAYMENT
2. Shoot will be canceled and no deposit will be returned

- If the Model cancels the modeling session, the Model agrees to refund any advance payment received from the Client.

## 6. Confidentiality

Both parties agree to keep all details of this Agreement confidential, except as necessary to carry out the terms of this Agreement or as required by law.

## 7. Miscellaneous

- This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, agreements, and understandings.

- Any amendments to this Agreement must be in writing and signed by both parties.

- This Agreement shall be governed by and construed in accordance with the laws of the state of TEXAS.
