1. Services Provided
The Model agrees to provide modeling services for the Client as described below:

2. Compensation
<ul> <li>- Hourly Rate: The Client agrees to pay the Model \$ per hour.</li> <li>- Package Rate: The Client agrees to pay the Model \$ per package (Brenna Package or Photographer Package).</li> </ul>
- Overtime Rate: The Client agrees to pay the Model \$ per hour for any time exceeding booked time slot. Any overtime is solely at the model's discretion and availability.
3. Payment Terms

## 4. Rights and Usage

## 5. Cancellation Policy

- 24hr client cancellation notice will allow client to rebook model and use \$100 deposit within 30 days of canceled date notice
- "Day of" client cancelation = no deposit return
- Client tardiness 30min or greater to booking date will either
  - 1. allow shoot to still happen and will still end at time stated on contract. photographer MUST still pay for FULL MODEL PAYMENT
  - 2. Shoot will be canceled and no deposit will be returned
- If the Model cancels the modeling session, the Model agrees to refund any advance payment received from the Client.

## 6. Confidentiality

Both parties agree to keep all details of this Agreement confidential, except as necessary to carry out the terms of this Agreement or as required by law.

## 7. Miscellaneous

- This Agreement constitutes the entire agreement between the parties and supersedes all prior negotiations, agreements, and understandings.
- Any amendments to this Agreement must be in writing and signed by both parties.
- This Agreement shall be governed by and construed in accordance with the laws of the state of TEXAS.
